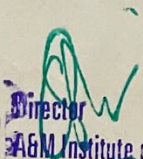
- A & M Institute of Management and Technology, Pathankot will select students from various Departments of A & M Institute of Management and Technology, Pathankot.
- Selected students of A & M Institute of Management and Technology, Pathankot will attend lectures

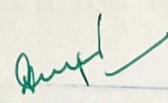
