

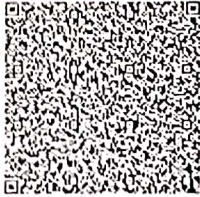

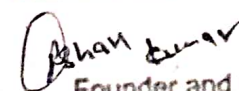

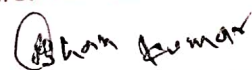

3. Terms and Conditions:

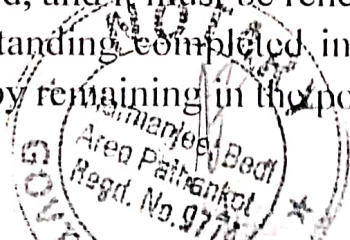
Types of Cooperation:-Through this memorandum, both Parties affirm the value of collaboration and agree to promote the following activities:

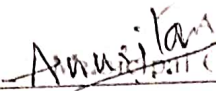
